

There is no effective ethics oversight, conflict-of-interest rules are weak, and there's nothing stopping legislators from taking lucrative lobbying jobs immediately after leaving office. Weak policies encourage corruption and the lack of transparency means voters are unable

to hold their elected officials accountable.

which would finally bring Michigan's government up from the bottom of the barrel. Unfortunately, the pandemic hit just as we were making signifcant progress on the bills.

Not to be deterred, we see a rare and valuable opportunity in 2021 to advance a sweeping package of ethics, transparency, and accountability reforms that will change the political landscape of Michigan for decades to come.

Proposal 2

Voters Not Politicians started as a citizen-led ballot initiative that reformed the redistricting process in Michigan in 2018. To end gerrymandering and truly unrig our elections, however, we must make sure the law is implemented as the people intended: in a fair, transparent and impartial way.

Overseeing Implementation

2020, VNP volunteers played

a significant role in the state's recruitment of 9,367 applicants for the Commission by educating voters and supporting them step-by-step through the application process. Protecting From Legal Attacks

Since 2019, VNP has defended the ICRC against legal challenges brought by the Michigan

challenges brought by the Michigan Republican Party and the Michigan Freedom Fund, and we have won at every stage. We thought we could finally close the books on these meritless lawsuits in 2020, after both the District Court and 6th Circuit Court of Appeals upheld the Commission as constitutional.

But the legal fight continues. In November of 2020, Tony Daunt of

the Michigan Freedom Fund appealed the dismissal of their case. The case is once again before the Sixth Circuit Court of Appeals, and it may go all of the way to the U.S. Supreme Court in 2021.



VoteSafe

Voters Not Politicians launched the VoteSafe campaign in the spring of 2020 to ensure that no voter would have to risk their life to exercise their right to vote.

The VoteSafe campaign raised awareness among voters of their right to cast an absentee ballot without providing a reason, one of the hallmarks of the "Promote the Vote" constitutional amendment passed by the voters in 2018. VNP also mobilized our grassroots army to advance legislation to make absentee voting and vote-by-mail more safe, secure and convenient; and held elected officials accountable for their opposition to vote-by-mail policies.

VNP identified which state legislators support voteby-mail by administering a questionnaire to all sitting legislators and state house candidates. Candidates



who passed were given the "VoteSafe Approved" stamp to let voters know that the candidate supported VNP's pro-voter agenda.



VNP Executive Director Nancy Wang led a team of experts, including Michigan Secretary of State Jocelyn Benson, on voting access and vote by mail during a VoteSafe Townhall on May 21, 2020.

In addition, VNP launched a robust campaign, using text and phone banks, digital ads and direct mail, to inform voters in 5 key competitive Michigan House districts on where their legislators and candidates stood on voters' rights. Of the 57 VoteSafe-approved candidates, 42 were elected to the Michigan House, a success rate of approximately 74%.

Advocating for a Pro-Voter Legislative Agenda

VNP mobilized volunteers on two fronts: contacting voters by phone and text to inform them about VoteSafe legislation, and calling Michigan legislators directly in support of key bills through our Dial for Democracy Program. We successfully advocated for an amendment to Public Act 116, which allowed clerks in larger municipalities to process ballots the day before Election Day, and provided a requirement that clerks notify voters if a signature error that would invalidate their absentee ballot.

Activists across the political spectrum agree that picking up the phone and calling your elected officials is one of the most effective ways to make your voice heard. Many elected officials and their staff members have stated that a phone call from a constituent holds more weight than an email or a tweet. Nights & Weekends

In addition to passing redistricting reform in 2018, Michigan voters passed Proposal 3, the Promote the Vote amendment to expand voters' rights in Michigan.

Proposal 3 permits no-reason absentee voting and same-day registration. In 2020, 3.2 million Michigan voters took advantage of these rights by casting an absentee ballot by mail, at a drop box, or at their clerk's office before election day.

Proposal 3 also requires that all clerks' offices be open for at least 8 weekend hours immediately before election day. However, Proposal 3 sets a floor, not a ceiling. Each of Michigan's 1,520 city

and township clerks have wide discretion to provide greater voting access in their jurisdictions.

To maximize the benefits of Proposal 3 for voters, VNP mobilized our grassroots volunteers to advocate for

expanded voting access in their communities. Our Nights & Weekends program uses our organization's lean staff and expansive network of volunteers to

engage city and township clerks. In 2020, we maintained, organized, and trained 26 active teams across Michigan. The program demonstrates the power of meaningful engagement with local officials. VNP volunteers helped expand clerk's office hours for early voting and registration by a total of 261.5 hours in 17 municipalities, benefiting 802,662 registered voters.

Nights & Weekends not only made voting more convenient in 2020, it also made voting during the pandemic

safer by reducing long lines and crowding on the day of the election. Moreover, VNP's volunteer teams continue to build upon their relationships with clerks to effect more pro-voter change on the local level.





People-Powered Success in Kalamazoo

VNP's success in the Nights & Weekends program in Kalamazoo provides a shining example of "the power of the people." In 2020, VNP volunteer, Jessica Swartz, led a months-long effort to expand voting access in the city.

Jessica organized a team of VNP volunteers: formed partnerships with four community organizations advocate for ballot drop box locations, prepaid postage for return and expanded ballots. clerks' office hours on nights and weekends; and met with the City Clerk Commission and Citv members. Jessica's team collected over 100 petition



signatures calling for the City Commission to pass a resolution and Jessica gave public comment at several public meetings to support the effort. As a result, the City Commission unanimously passed a resolution that established 4 ballot drop boxes, provided pre-paid postage for absentee ballots, and increased the clerks' office hours by 16 hours on nights and weekends leading up to election day.

One of the teams biggest wins was a satellite office Western Michigan on University's campus. The City Commissioner who introduced the resolution acknowledged the role Jessica and her team played in the Commission's decision to pass the measures. The expansion of voting access in the City of Kalamazoo

for the 2020 election can be directly attributed to the tireless efforts put forth by passionate VNP volunteers and community partners.



Voters Not Politicians' journey to end gerrymandering started with a facebook post in November 2016, when a group of internet strangers, all political novices, came together to take on gerrymandering in Michigan. Our group quickly grew from hundreds to thousands of volunteers who came from a variety of backgrounds – from retirees and students to veterinarians and lawyers, young and old, of different political stripes.

Against the odds, our citizen-led campaign ended gerrymandering with the overwhelming approval of Michigan voters (61%) on November 6, 2018.

VNP continues to defend and promote policies that strengthen democracy. Michigan's government must truly represent the will of the people, all votes must count equally, and all voices must be heard. Our representatives must not be unduly influenced by lobbyists or special interests or motivated by personal gain.


